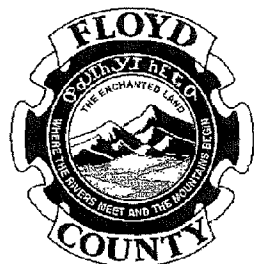

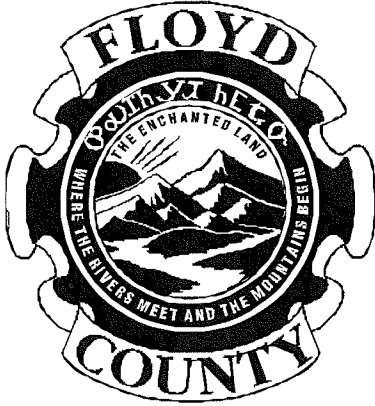
Sealed bids were opened July 15, 2014 for Paint and Sign Material, this is a one year price agreement to provide items on an as needed basis.
