## **Scope of Work**

The Floyd County Jail located at 2526 New Calhoun Highway has one (1) roll up door needing repair and three (3) rollup doors needing replaced. These doors are motorized Cornell Rolling Steel, (10' Wide by 12' in Height). Doors are identified as NE1, NE2, SW1, and SW2.

#### **CONTRACTOR WILL:**

- Provide all labor and materials at contractor's expense.
- Replace Doors NE1, SW1, and SW2 with the exception of Motor and Tracks.
- Repair Door NE2
- Leave all doors in an optimal working condition at project completion.
- Turn over all remaining doors and parts to the owner at completion
- Follow all Jail Security Rules and Regulations.
- Coordinate project with Ryan Davis, Facilities Manager during the performance of work and not deviate from the scope of work without prior of approval.
- Complete all work Mondays through Fridays 8am to 5PM excluding legal holidays.
- Contractor will secure entrances and remove all contractor tools and equipment from the work location daily.

**CONTRACTOR MAY:** Use parts from the removed doors to make repairs to Door NE2 so as long as parts are in a serviceable condition and the parts used will not degrade the lifespan of the repaired door.

**ACCEPTANCE:** Ryan Davis will perform the acceptance inspection with contractor and once approved the contractor will submit invoice for payment.

#### **FLOYD COUNTY WILL**

- Provide access to work area and provide security brief of Jail Rules and Regulations regarding Jail Security
- Provide payment within 30 days of being presented a valid invoice.

#### **MATERIALS**

Doors materials will be of similar design, quality, and gauge of metal of the existing Cornell Rolling Steel Doors (Galvanized Steel). Doors NE1 and NE2 perforated Slates are full height and Doors SW1 and SW2 are 3/4 Height.

All doors at completion will have solid slates for the top 1/4 and perforated slates at bottom 3/4.
