Notice is hereby given that the City of Rome will receive sealed bids from interested parties until **February 20, 2018 at 11:00 a.m.** at its offices located at 601 Broad Street, Rome, Georgia 30162-1433.

Any bids received thereafter will not be considered.

Bids will be publicly opened and read at the City of Rome Purchasing Department located at 601 Broad Street on the day and at the hour specified.

The purchaser may consider as non-responsive, any bid in which there is an alteration of, or departure from the bid form hereto attached.

The bid will be awarded to the lowest reliable bidder complying with the conditions of the invitation for bid. The bidder to whom award is made will be notified at the earliest possible date. The purchaser reserves the right to reject the bid of a bidder who has previously failed to perform properly or complete on time, contracts of a similar nature, or the bid of a bidder who, in the sole opinion and discretion of the purchaser is not in a position to perform the contract, or whose name appears on the United States Comptroller General's list of ineligible contractors.

Bids may be withdrawn by written or faxed request, provided such withdrawals are received prior to bid opening date.

FOUR (4) POLICE PURSUIT/ SPECIAL SERVICES VEHICLES

The purpose of this specification is to describe new Ford Interceptor SUV Police vehicles as described. The use of a brand name does not indicate a preference for that brand. It is intended to establish a level of quality, function and reliability. Vehicle should be delivered complete and ready to operate.

- A. SCOPE: This specification covers **Four (4) Police Pursuit/Special Services SUV's** having Four Wheel or All Wheel Drive, excellent acceleration, speed, braking, and handling performance. **Please Note: Two of these vehicles will be for patrol purposes while the other two will be administrative vehicles.** Although the City of Rome intends to purchase Four (4) of these vehicles, we would like to reserve the option to purchase an additional Two (2) Police Pursuit/Special Services SUV's from this bid solicitation. This option must be exercised within 12 months of the date of issue of the original purchase order.

- B. VENDOR INFORMATION: Police Pursuit vehicles shall be equipped with factory installed Police Packages plus additional dealer installed items listed below. Unless otherwise noted, vehicles shall be comparable with the following basic requirements. Bidders shall indicate EXACTLY what they are offering under "BIDDER'S RESPONSE."
